I. NIDAAMKA DUBLIN

VI. MUDADA UU QADANAYO NIDAMKA DUBLIN

Waqtiga xaddidan ee jawaabta la wareegida codsiyada noocan ahi waa:

- ▶ Waxa luku diwaan galiya 2 billood hadi faraha laka qaday e isku mid noqdaan faraha ku jiro mesha wax luku kediyo maclumadka ee luku magacabo eurdac;
- ▶ Aan ka badnen hal billood hadi xalad degdeg eh la soo waco.

Kabacdi marke laka gudbiyo dalbkaga magan-galyo donka, waa la xalin dona:

- ▶ Waxe qadata 3 billood hadi faraha laka qaday ee isku mid ee noqon faraha ku jiro mesha wax luku kediyo ee luku magacabo eurdac;

Nidamka dublin ee badalida waxa luku dhameya:

- ▶ 6 billood gudaheda tariqada luku aqabalay kabacdi;
- ▶ Waxe qadata 18 billood qofka hadi la wayo ama u ka cararo badalida;
- ▶ 12 billood haddii qofku ku qaadanayo xukun xabsi ah.

Waad ka doodi kartaa go'aanka lagu diiday marinkiina magangalyo ee romania isla markaana lagu wareejiyay xubinta mas'uulka ah, waxa ku gudbin karta cabasho 5 bari gudaheda malinta go'aanka la garay.

Cabasho la xareeyay sida halkan iyo kor ku xusan ma hakin doonto u wareejintaada wadanka xubinta

mas'uulka ka ah. Markaad xareysid cabashada waxaad si cad u codsan kartaa in la joojiyo fulinta go'aanka wareejinta.

Cabashada waa in loo gudbiyaa kormeeraha guud ee waaxda socdaalka iyo magangalyada ama si toos ah maxkamada awooda u leh ee awooddeeda ay ku tallo xarunta hoyga iyo nidaamka ee aad ku nooshahay, waana inaad ku lifaaqdaa halkaan nuqul ka mid ah go'aanka la soo gudbiyey oo aad codsatid in si cad loo joojiyo wareejinta.

Waxa wadesan karta maxkamada ine ku seso garyaqaan ku difaco! Maxkamada waxe firin donta ama falanqen donta cabashadad waxe go'aan ku gari donta 30 bari gudahes!

VII. XUQUUQDA AAD XAQ U LEEDAHAY INTA LAGU GUDA JIRO HOWSHA DUBLIN

- ▶ Waxa xaaq u ledahay in luku dajiiyo xarumaha soo dhaweynta iyo hoyga ee igi/dai;
- ▶ Waxa xaq u ledahay helida daryeelka aasaasiga ah iyo kan degdega ah ee isbitaalka.
