WAA MAXAY NIDAAMKA MAGANGALYO – DONKA EE WADANKA (ROMANIA)?



Wadamda bixiyo qaxotiga waxe aqbalan dalbka uku yimado qofka qoxotiga dalbado oo dhib ka hesto wadan kisa ama wadan lahen, sababto eh cabsi u ka qabo in lo xero ama lo maxkamadeyo asga ama ayada jinsiyad ahanatoda, ama dintoda, ama wadankoda, ama arima siyaasaded ama inu xubin ka aha koox bulsho gaar eh. Oo ka baxsan dalkisa hooyo oo aan awoodin ama cabsi darted. Ma donayo ilaalinta dalkisa ama dalkeda.

1. Gadib xarenta codsiga ee magan-galyo donka ee calimega, waxa laka qada sawir iyo farahka la sawira markas kabacdi waa luku diwaan galina. sawirada laka qaday oo ka mid tahay farahaka waxa luku xarena kombiyuutarka e ku midesan yihiin wadamada bixiyo qaxotiga yurub oo lo so gabiyo magacoda EURODAC. Kabacdi waxa luku sinaa kar aqonsi ku meel-gaar eh oo ku qoran magacaga.
2. Waxa xaq u leedahay inaa hesho cawinaad, waxa dalban karta codsi, lataliye sharci kaso laka helo hayadaha (NGO) IYO (UNHCR), kas ka bilawaneso malinta codsiga dhibatay ilaa laga qadanayo go'aan arintada. Cawinta ee ku cawinayan hayadaha waa bilaash. Waxa sido kale xaq u leedahay inaa cawin ka hesho garyaqaan aad adiga dorato (sido kale garyaqaan kas qarashkisa adiga aya iska dhibato).
3. Waxa balan ka heli donta xafiska socdalka

- (IGI) balantas oo eh in laba waresi lukula yelan dona ku waso luku go'aamin dona inaa lukugu siyo magan-galyo. Waa muhim inaa ka so qeeb gasho labada waresi waa ina si dacad eh uku jawabta waresiga luku la yelan dono.
4. IGI waxe ku shegi donta go'aanka laka garay dalbkaga magan-galyo donka . Hadi aad ku qancin go'aanka e ka gartay hayda socdalka (IGI) , waxa xaq u ledahy in ka gudbeso cabasho go'aanka ee gartay hayada socdalka waxa u gudbin karta hayada socdalka (IGI) ama maxkamada u qaska eh arimaha qaxotiga:
 - ▶ 10 malin gudeheso
 - ▶ muddo 7 maalmood gudahood ah laga bilaabo taariikhda isgaarsiinta (xawaareynta/nidaamka xadka)
 5. Maxkamada qaxotiga we dhage san donta cabashadada (maxkamada kowad) waxe ku si donta balan o uku so qeeb gasho dhagesiga

maxkamada (Balanta waxa lukugu so diri dona mesha dagan tahy aad horay u shegatay.)

6. Waxaad xaq u leedahay caawimaad sharci oo bilaash ah si aad uga faa'iideysato o ku difaaco, waxa heli karta cawimaad ka socoto:
 - ▶ hayda latalinta dhinaca sharciyada oo lo sogabiyo (CNRR)
 - ▶ ama garyaqaan ee maxkamada ku qabaneso.
 - ▶ Ama adiga aya garyaqaan qabsan karo (kaas o ee tahay inaa qarash kisa iska dhibto).
7. Cabashada aad gudbeso hadi ee so dido maxkamada qaab qoraal eh, waxa xaq u ledahy inaa dhaado waa ka so horjeda go'aankas waxan qadan karta racfaan (waa ina u gudbesa hayada socdalka ee lo so gabiyo IGI ama maxkamada la timid go'aanka ay kaga horyimid racfaankaga) 5 bari gudaheda laka bilawa malinta luku siyay jawabta, waxa hesata 10 bari inaa ku xareso racfaan laka

bilba malinta maxkamada ku sesay go'aanka. Maxkamada waxe dhagesan donta racfaanka (maxkamada dagmada) aya ku sin donto go'aanka uku danbeso.

8. Haddii dacwadaada ay diido maxkamada ugu horeysa, oo sidaas ku sii wadata go'aanki ay ku diiday dalabkiina magangalyo ee habsami u socodka howlaha lagu qabtay xadka, xukunka maxkamada darajada koowaad ayaa ah kii ugu dambeeyay.
9. Haddii ay dhacdo go'aanka kama dambaysta ah ee lagu diido dalabkaaga magangalyo nidaamka caadiga ah, waxaa kugu waajibaya inaad uga baxdo wadanka romania 15 maalmood gudahood. Haddii aad hesho go'aan diidmo ah oo ku saabsan dalabkaaga oo lagu falanqeyay hanaan dardar ah oo lakugu qabtay xadka, waxaa waajib kugu ah inaad ka baxdo waddanka isla marka hawsha magangelyada la dhammaystiro.
